ANNOTATED PROVISIONAL AGENDA

1. Opening of the meeting

The meeting will be opened by the Chair of the Project and Programme Review Committee (PPRC), Ms. Yuka Greiler (Switzerland, Western European and Others Group).

2. Organizational matters

Background: Following new contributions made in and after the tenth session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol, the pipeline of proposals has been cleared of projects.

Action expected: the secretariat will give an overview of the availability of funds to fund project and programme proposals.

4. Report of the secretariat on the intersessional review cycle

Document: AFB/PPRC.17/3 <u>Report of the secretariat on the intersessional review</u> cycle

Background: At its twenty-third meeting, the Board, having considered the comments and recommendation of the Project and Programme Review Committee (PPRC), decided (Decision B.23/15) to:

- (a) Arrange one intersessional project/programme review cycle annually, during an intersessional period of 24 weeks or more between two consecutive Board meetings, as outlined in document AFB/PPRC.14/13;
 - [...]
- (h) Request the secretariat to present, in the fifteenth meeting of the PPRC, and annually following each intersessional review cycle, an analysis of the intersessional review cycle.

In its fifteenth meeting, the PPRC discussed the first such analysis as referred to in (h) above, contained in document AFB/PPRC.15/3.

At its twenty-fifth meeting the Board decided to:

- (a) Amend Decision B.23/15 and require that all first submissions of concepts under the two-step approval process and all first submissions of fullydeveloped project/programme documents under the one-step process continue to be considered in regular meetings of the Project and Programme Review Committee (PPRC);
- (b) Request the secretariat to review, during its inter-sessional review cycles:
 - (i) First submissions of fully-developed project/programme documents for which the concepts had already been considered in regular meetings of the PPRC and subsequently endorsed by the Board;

- (ii) Resubmissions of project/programme concepts and resubmissions of fully-developed project/programme documents;
- (c) Request the PPRC to consider intersessionally the technical review of such proposals as prepared by the secretariat and to make intersessional recommendations to the Board;
- (d) Consider such intersessionally reviewed proposals for intersessional approval in accordance with the Rules of Procedure; and
- (e) Inform implementing entities and other stakeholders about the updated arrangement by sending a letter to this effect, and make effective such amendment as of the first day of the review cycle between the twenty-fifth and twenty-sixth meetings of the Board.

(Decision B.25/2)

Pursuant to decision B.23/15 (h), the secretariat has prepared and submitted to the PPRC document AFB/PPRC.17/3 which analyses the last intersessional review cycle.

Action expected: The secretariat will present the document AFB/PPRC.17/3. The PPRC may want to discuss the report and, if it wishes to, make a recommendation to the Board on the way forward.

5. Report of the secretariat on initial screening/technical review of the submitted project and programme proposals

Background: In its twenty-fifth meeting, the Board decided to:

- (b) Set a cap of US\$ 30 million for the programme;
- (c) Request the secretariat to issue a call for regional project and programme proposals for consideration by the Board in its twenty-sixth meeting; [...]

Pursuant to decision B.25/28 (c), the secretariat issued, on 5 May 2015, an invitation to submit project and programme proposals for funding under the pilot programme. The secretariat received a number of eligible proposals that it has subsequently reviewed.

Action expected: The PPRC will be invited to consider the project/programme proposals submitted with their corresponding technical review sheets, and the final

consolidated comments of the secretariat. Further, the PPRC will be invited to make recommendations on each proposal to the Board for adoption. The PPRC will also be invited to consider the Project Formulation Grant requests contained in respective documents and to make recommendations on them to the Board for adoption.

8. Analysis of climate change adaptation reasoning in project and programme proposals approved by the Board

Document: AFB/PPRC.17/4 <u>Analysis of climate change adaptation reasoning in</u> project and programme proposals approved by the Board

Background: At the twenty-fifth meeting, following a discussion that took place at the PPRC in its sixteenth meeting about the importance of capitalizing on the experience of the projects' climate change reasoning so that the Fund's experience with concrete adaptation projects and programmes could be highlighted to other international actors that were also interested in climate change, the Board decided to request the secretariat to present, for consideration of the PPRC at its seventeenth meeting, an analysis of how project and programme proposals approved by the Board have addressed climate change adaptation reasoning, especially at the local level, based on the review criteria approved by the Board (Decision B.25/16).

Action expected: The secretariat will present the document AFB/PPRC.17/4. The PPRC may want to discuss the findings and suggested recommendations, and make a recommendation to the Board on the way forward.

9. Other matters

Action expected: The PPRC will be invited to discuss any other matters raised during the adoption of the agenda.

10. Adoption of the report

Document: The report of the PPRC will be prepared after the afternoon session on 7 October 2015, for adoption after the afternoon session of the Board meeting on 8 October 2015.

Action expected: The PPRC Chair will report to the Board on the deliberations of the PPRC and on agreed recommendations to the Board.
