REPORT ON ACTIVITIES OF THE CHAIR

- 1. During the intersessional period between the forty-second meeting and the forty-third meetings of the Adaptation Fund Board (the Board), the Chair, Lucas di Pietro (Argentina, Non-Annex I Parties) carried out the below-listed activities for the Fund.
 - (a) Finalized the report of the forty-second meeting, assisted by the secretariat;
 - (b) Represented the Board in a meeting among chairs of Multilateral Climate Funds (MCFs), on 24 May 2024, on the topic of the joint action plan of the MCFs;
 - (c) Attended the 60th session of the Subsidiary Bodies to the UNFCCC from 9 to 13 June 2024 as part of the Adaptation Fund Board delegation including:
 - Delivering opening remarks at the AF side event titled "Delivering on the Global Goal on Adaptation: Perspectives and Opportunities from the Adaptation Fund";
 - Delivering opening remarks at a dedicated briefing and outreach event for contributor governments organized by the secretariat to support resource mobilisation by the Fund.
 - Engaging with Parties and constituencies, together with the secretariat;
 - (d) Represented the Fund along with a member of the secretariat at the third meeting of the G20 Sustainable Finance Working Group and the Task Force Clima (9-12 July 2024, Belem, Brazil);
