# WORK PROGRAMME UPDATE REPORT OF THE TECHNICAL EVALUATION REFERENCE GROUP OF THE ADAPTATION FUND (AF-TERG)

PROGRESS FOR FISCAL YEAR 2024 - 2025 (FY25)

# **Background**

- 1. The Technical Evaluation Reference Group of the Adaptation Fund (AF-TERG) is an independent evaluation advisory group, accountable to the Adaptation Fund Board (hereafter, 'the Board'), and functionally independent of the Adaptation Fund Board secretariat (hereafter, 'the secretariat'). It was established to ensure the independent implementation of the Adaptation Fund's (hereafter, 'the Fund') Evaluation Framework, which has been replaced by the Evaluation Policy in October 2023.
- 2. The AF-TERG has been operational since 1 July 2019 and is comprised of an independent group of five members, including the Chair, who provides strategic leadership. The AF-TERG is supported in the implementation of its work programme by a full-time secretariat, led by a Secretariat Coordinator/Senior Evaluation Officer and consisting of a Programme Assistant and an Evaluation Officer (Extended Term Consultant, under recruitment). Technical expert consultants and corporate vendors are hired on a short-term basis to implement specific work elements.
- 3. In determining its work priorities, the AF-TERG was guided by its first strategy and three-year work programme, and from July 2024 by its second multi-year work program. The AF-TERG takes direction from the Ethics and Finance Committee (EFC) and the Fund Board and is informed by the evaluative needs of the Fund's key stakeholders and the relevant guidance from the various bodies of the UNFCCC, while also guided by the Fund's Evaluation Policy. The Fund's Board endorses AF-TERG activities through the multi-year work programme and approves the annual workplan and budget as part of the AF workplan and budget.
- 4. On 4 June 2020, the Board approved, through inter-sessional decision B.35.a-35.b/29, the first strategy and three-year work programme of the AF-TERG for 2021-2023 (AFB/EFC.26.a-26.b/3). At the thirty-eighth meeting of the Board, the Chair of the AF-TERG presented an update of the work programme for fiscal years 2023 and 2024 (AFB/EFC.29/7). Adjustments for FY23-24 and a new budget for FY24 were approved by the Board as part of decision B.38/47.
- 5. In April 2024, through decision B.42/46, the Board approved the second multi-year work programme of the AF-TERG for FY25-27 (AFB/EFC.33/.6/Rev.1) and through decision B.42/45 the annual budget of AF-TERG and its secretariat for FY25.
- 6. The AF-TERG's second multi-year work programme is framed under the three functions as defined by the Evaluation Policy and the revised AF-TERG Terms of Reference (ToR) (Decision B.42/47). These include: (a) the generation of evaluations, comprising evaluation management, advisory and oversight functions; (b) evaluation utilization; and (c) evaluation capacity building. In relation to the two new functions of evaluation utilization and evaluation capacity building, and in line with decision B.42/47 para (b), the AF-TERG will continue to seek collaboration with the secretariat with a view to ensure synergies and synchronize outreach to the Fund's stakeholders.

#### Introduction

- 7. This work programme update report seeks to present a mid-year update of progress on the first year (FY25) of the AF-TERG's second multi-year work programme (FY25-FY27), and also covers work completed under the first multi-year work programme, which ended in June 2024 and is yet to be reported to the EFC. Three accompanying annexes serve as background information and include the following: a summary of the activities conducted under the first work programme (Annex 1); summary of AF-TERG external outreach activities (Annex 2); and a rolling list of reports delivered by the AF-TERG to the Board since FY20 (Annex 3).
- 8. The AF-TERG is separately submitting to the EFC's thirty-fourth meeting in October 2024 the following documents:
  - (i) AF-TERG's third thematic evaluation on scalability, lessons and evidence from the Fund and broader peers, including recommendations on supporting scalability through Fund (and AF-TERG) strategy and operations (AFB/EFC.34/5)
  - (ii) Information notes containing ex post evaluation summaries for two ex post studies in Argentina, undertaken in 2023, namely, #3: "Increasing Climate Resilience and Enhancing Sustainable Land Management in the Southwest of the Buenos Aires Province" (ARG/MIE/Rural/2011/1), which was implemented by the IBRD from 2015 to 2019 (AFB/EFC.33/Inf.3); and #4: "Enhancing the Adaptive Capacity and Increasing Resilience of Small-Size Agriculture Producers of the Northeast of Argentina" (ARG/NIE/Agri/2011/1), which was implemented from 2013 to 2018 by Unidad para Cambio Rural Argentina (AFB/EFC.34/Inf.4).
- 9. It is noted that during the reporting period, the AF-TERG operated with five members, including the Chair, until the end of June 2024 and only with four members in FY25, while awaiting the conclusion of the recruitment of a new member. Systems have been put in place to minimize the impact of that temporary disruption, including redistribution of workload among AF-TERG members and the AF-TERG secretariat.

#### Information update to EFC on the work programme

- (a) Evaluation Policy: guidance notes and introduction to fund stakeholders
- 10. In April 2022, the Board requested the AF-TERG to develop, in consultation with the secretariat, evaluation guidance documents for the implementation of the Fund's Evaluation Policy, including budget implications (Decision B.38/48). The AF-TERG has since produced a total of 12 guidance notes, which are available on the AF website. All 12 guidance notes are available in English and Spanish and are currently being translated into French.

- 11. As part of the second work programme, a new guidance note, *Evaluation in Project Design* (No. 13), has been drafted and is currently undergoing consultation with stakeholders. The guidance is designed to support compliance with the Evaluation Policy and aims to contribute to the design of fund-supported projects that can produce high-quality evaluations and valuable learning. The AF-TERG previewed the new guidance and solicited feedback from Implementing Entities in a presentation on 31 July delivered at a webinar organized by the Readiness Programme of the Fund. This webinar built on another Readiness Programme webinar in the Spring of 2024 where the AF-TERG joined with a presentation on Evaluation Policy compliance at the proposal stage.
- 12. The AF-TERG also initiated the development of a video training (eLearning) on the evaluation policy. The video training will be targeted at Implementing Entities and will provide practical guidance on the application of the Evaluation Policy at different stages of the project development and implementation.
- 13. Finally, the AF-TERG continues working with the secretariat to ensure that all funding proposals submitted to the Adaptation Fund and all projects approved since the Evaluation Policy came into effect are compliant with the policy.
- (b) <u>Progressing the Comprehensive Evaluation of the Fund and the midterm review of the second Medium-Term Strategy of the Adaptation Fund</u>
- 14. The AF-TERG's first multi-year strategy and work programme provisioned for an overall evaluation of the Fund. The Board reviewed the options presented by the AF-TERG (AFB/EFC.31/Inf.2, paras. 16-20) and decided to adopt a phased approach (AFB/B.39/14, Decision B39/57)<sup>2</sup>: to proceed urgently with a Rapid Evaluation, followed by a Comprehensive Evaluation, with the aim of contributing to the development of the Fund's Medium-Term Strategy for 2028-2032.
- 15. As per Board decision B.39/57 and B.40/72, the Comprehensive Evaluation of the Fund is to be delivered 60 days before B.47 (i.e. by August 2026) and a midterm review of the Fund's MTS 2023-2027 by B.46 (i.e. March 2026).
- 16. The Rapid Evaluation study was conducted between February and July 2023, and the findings and evidence gaps were submitted to the secretariat and EFC through document AFB/EFC.32/.6/Rev.2³ in August 2023, as requested by the Board.

17. The AF-TERG initiated the development of ToRs for both evaluations and presented the proposed approaches in document AFB/EFC.33/10<sup>4</sup>. As requested by the Board in decision B.42/50, the AF-TERG, after consultations with the AFB secretariat, presented the draft ToRs to the EFC during the intersessional period between the forty-second and forty-third meetings of the Board (AFB/EFC.33-.34/Inf.1). Once the ToRs are cleared by the Board, the work will be tendered through two separate corporate procurement processes. The AF-TERG aims to conclude the procurement process for consulting firms by December 2024 so that the work can begin in early 2025 as planned.

#### (c) Thematic evaluations

- 18. A suite of three thematic evaluations, identified as part of the first work programme, have been completed. The evaluations were identified following initial consultations with Board members, Implementing Entities, and secretariat staff as relevant to the evolving context of the Fund. The first study on the Fund's experience with **innovation** was presented to the EFC for consideration and recommendation for Board approval (AFB/EFC.30/10, October 2022). The second thematic evaluation on **accreditation** was submitted to the EFC at its thirty-third meeting (AFB/EFC.33/Inf.4). The management response is expected to be presented by the secretariat at EFC. 34 in October 2024.
- 19. The third thematic study on **scalability**, after being deferred from EFC.33, will be presented to the EFC at its thirty-fourth meeting (AFB/EFC.34/5). The objective of this thematic evaluation is to derive lessons about the Fund's efforts and progress in the design and delivery of projects that are scalable and to look at the performance of the investments made by the Board for this purpose. The study includes an assessment of the strengths and potential of the Fund as a supporter of scaling and a portfolio analysis of scaling in projects in the Action Pillar of the Fund's work. The evaluation makes recommendations for the Fund to manage scaling support going forward, leveraging existing activities and indicators in the Implementation Plan of the Medium-Term Strategy. The management response is also expected to be presented by the secretariat at EFC.34.
- 20. The MTS-2 Implementation Plan identified a thematic evaluation of the Fund's **readiness programme** as a priority, which led to its inclusion in the AF-TERG's workplan for FY25. The AF-TERG, with inputs from the secretariat, developed and finalized the ToR, and opened a corporate procurement tender in August 2024. The work is planned to start in October 2024 and is intended to provide evidence and learnings to inform the Fund's new readiness strategy.

# (d) <u>Information update on phase 2 of the ex post project sustainability evaluations</u>

- 21. Under its first work programme, the AF-TERG developed a methodology for ex post evaluation of adaptation projects and has so far applied this to four ex post evaluations. The first two ex post evaluations were conducted for projects in Samoa and Ecuador (2022), and the next two were completed for projects in Argentina (2023). A key development is that the AF-TERG shifted its mode of contracting from the use of single consultant evaluators during the pilot ex post evaluations to the procurement of a corporate vendor (consulting firm) for the third and fourth ex post evaluation. This approach has been found to be more efficient and is expected to be applied to all future ex post evaluations. The findings from the third and fourth ex post evaluations (AF/EFC.33/Inf.6 and AFB/EFC.33/Inf.7) were discussed with the Implementing Entities, and will be presented to the EFC at its thirty-fourth meeting.
- 22. Under its second multi-year work programme, the AF-TERG has planned to deliver two ex posts annually. For FY25, the AF-TERG shortlisted two eligible completed projects for the upcoming comprehensive ex post evaluations from a pool of 18 Fund projects that fall within the 3-to-5-year post-completion window. These fifth and sixth ex post evaluations will address the sustainability of all project outcomes. Ex post evaluation #5 will take place in Mauritania and will evaluate the project "Enhancing Resilience of Communities to the Adverse Effects of Climate Change on Food Security in Mauritania," which was implemented by the World Food Programme. The tender for conducting this evaluation is in its final phases and the work is expected to start in late September 2024.
- 23. The AF-TERG plans to pilot its ex post approach in fragile and conflict-affected situations, most likely in a country in Africa, for the sixth ex post evaluation (#6). The AF-TERG is in the process of seeking agreement of the concerned Implementing Entities and the country government.
- 24. Finally, the AF-TERG has developed a toolkit for ex post evaluations of Fund projects which will be finalized after a consultative public review process (currently ongoing), most probably in October 2024.

# (e) Synthesis of final evaluations

25. The second synthesis of final evaluations was completed in March 2024 and will be submitted to the EFC intersessionally between its thirty-fourth and thirty-fifth meetings. This second synthesis assesses the quality of a total of 12 final evaluations using a newly developed comprehensive methodology based on the Evaluation Policy. Over time, this is intended to help in tracking improvements in the quality of the Fund's project-level final evaluations, in line with the new Evaluation Policy, and with emerging lessons intended to inform future project design and management.

# **Forward priorities**

26. Over the remainder of the financial year (i.e., up to June 2025), the AF-TERG will complete the delivery of activities included in the workplan for FY25, as follows:

# (a) Launch of the Comprehensive Evaluation and the MidTerm Review of MTS 2

- 27. Once both ToRs are cleared by the Board, the procurement process will immediately start following the World Bank corporate procurement rules. TORs will be advertised through different channels and networks and the selection of the consulting firms is expected to be completed before the end of December 2024.
- 28. The inception phase is planned to begin in January 2025. This phase will be an important milestone to ensure that the selected firms fully understand the requirements of the TORs and are enabled to conduct the evaluations in an efficient and transparent manner, and the AF-TERG will work closely with the secretariat through this process.
- 29. All other evaluations identified in the work programme continue to be approached as building blocks to inform the Comprehensive Evaluation.

# (b) Next set of thematic evaluations

- 30. Upon finalization of the procurement process, the work on the thematic evaluation of **readiness** is planned to start in October 2024. The initial findings of the evaluation are expected in December 2024, so that they can inform the development and finalization of the new Readiness Policy of the Fund.
- 31. Additionally, Decision B.39/57 requested the Comprehensive Evaluation to follow an approach that encompasses both the findings from the rapid evaluation, as well as an evaluation of **the processes**, **systems and governance** of the Fund. This evaluation topic is included in the AF-TERG workplan for FY25 and the AF-TERG has initiated a process of consultation on the scope of work to inform the development of the ToRs.

#### (c) Continued support to guide implementation of the Evaluation Policy

32. The AF-TERG will continue to work closely with the secretariat to disseminate the Evaluation Policy and its guidelines, and to provide technical advice on its implementation. This will involve the development of online training resources (under procurement as of September 2024) to help guide Fund stakeholders in the application of the policy. The AF-TERG will develop additional guidance notes based on emerging needs of stakeholders and will participate in webinars and other events, with prioritised outreach to those projects that are required to apply the Evaluation Policy in FY25. The AF-TERG will also continue to work with the secretariat to ensure that project reviewers address compliance with the Evaluation Policy into their reviews of funding proposals.

# (d) Ex post evaluations

33. The work on ex post evaluations is a key element of the work of the AF-TERG and an input to the Comprehensive Evaluation of the Fund. As per the second multi-year work programme, two ex post evaluations will be conducted annually in FY25 (#5 and #6) and FY26 (#7 and #8), respectively, and four in FY27 (#9 to #12). This work, as well as the finalization of the ex post evaluation toolkit, is pioneering and has generated lots of interest within the climate adaptation and evaluation field. It potentially puts the Fund in a leading position in climate change adaptation evaluations and will not only help to generate evidence and learnings for the future work and programming of the Fund, but for other climate funds as well.

# (e) Communications and knowledge management

- 34. AF-TERG will continue contributing to the overall knowledge management and communication work of the Fund, while maintaining its independent function in line with the AF-TERG mandate and its ToR.
- 35. The AF-TERG plans to finalize its **communication strategy** in alignment with the new communication strategy of the Fund, as well as with the goals of the Fund's Second Medium-Term Strategy that outlines learning and sharing as one of the three pillars of the Fund. The AF-TERG has also contributed to the development of the relevant parts of the new Fund Knowledge Management Strategy, ensuring alignment with decision B.42/47 to ensure synergies and synchronization of the outreach to Fund stakeholders.
- 36. The second multi-year work programme of AF-TERG also focuses on the development of a **management action tracker** for all the strategic, thematic and portfolio evaluations conducted by AF-TERG on behalf of the Board. The AF-TERG secretariat developed an initial version of the management action tracker which was discussed during the FY24 in-person meeting in May 2024 in Prague, Czechia. The AF-TERG secretariat is currently reflecting on the comments received and aims to finalize the tool by December 2024.

#### (f) In-person meeting for FY25

37. The AF-TERG is planning to hold its FY25 in-person meeting on 13 - 15 January 2025 in Washington, D.C., United States.

#### (g) External engagement and outreach

38. The AF-TERG continues to participate actively in the virtual and in-person meetings of the evaluation units of the four climate funds, namely the Adaptation Fund, Climate Investment Funds (CIFs), the Global Environment Facility (GEF), and the Green Climate Fund (GCF), to ensure coherence and reflect relevant thinking on adaptation monitoring, evaluation and learning (MEL) in its approach and advice to the Board.

- 39. As part of the joint collaboration on knowledge and learning initiatives, the four climate funds are working together on two pieces of knowledge management work as follows:
  - a) AF-TERG is leading the joint work on the utilization of AI in climate change evaluations in collaboration with the other climate funds. Despite the fact that various evaluation teams across the developmental world are looking into the utilization of AI in evaluations in general, no work has really been done focusing on climate change evaluations. The four funds expect this groundbreaking work to shape further discussions on the topic, while looking both at the benefits of the use of AI, as well as the potential risks.
  - b) The AF-TERG is also collaborating in a joint study, spearheaded by the GEF Independent Evaluation Office, which will analyse how **transformational change** is conceived, operationalized, and evaluated within the portfolios of the four climate funds with the aim to identify and compare existing methodologies, frameworks, guidelines, and example reports from these funds to assess transformational change, highlighting similarities and differences. The ultimate goal is to provide recommendations to streamline the design, monitoring, and evaluation of transformational change work across the funds.
- 40. The AF-TERG Secretariat Coordinator will also join, on behalf of AF-TERG and as an observer, the forty-second meeting of the Accreditation Panel on 28 29 August 2024 in Washington, D.C., United States.
- 41. As part of its external engagements and outreach, which are designed to demonstrate the Fund's niche value, showcase results, and facilitate learning, the AF-TERG plans to participate in person in the Rockefeller Foundation's climate evaluation and learning convening in Bellagio, Italy (10 15 September 2024), the Adaptation Fund National Implementing Entity seminar in Johannesburg, South Africa (16 20 September 2024), and the European Evaluation Society Conference in Rimini, Italy (23 27 September 2024). Additionally, AF-TERG participated in the Adaptation Fund Readiness Programme webinar on 31 August 2024 and plans to participate in the CIFs' events titled "Lessons on Financing Forest Management" on 5 September 2024, as well as "Learning for Transformational Change" on 15 17 October 2024. Over the next few months, AF-TERG representatives plan to join the Fund delegation at the upcoming COP29 in Baku, Azerbaijan, and the next United Nations Evaluation Group EvalWeek and Annual General Meeting on 10 14 February 2025 in Tokyo, Japan.

#### **Budget update**

42. As reported in document AFB/EFC.34/4, the overall expenditure level of the evaluation function for FY24 was 63.8 per cent, with the execution rate on the management component of the budget standing at 84.5 per cent, and of the evaluation component at 39.3 per cent. While the expenditure on the management component is aligned with the expenditure projections, the expenditure on the evaluation component remained below the original projections.

- 43. The main reasons for the latter are linked to significant delays in procurement for some of the originally planned evaluation activities, due to delays in the clearance of the tendering documentation, as well as in the actual procurement process. This includes the thematic evaluation on readiness and the e-learning modules for the Evaluation Policy. Another reason for the low execution rate was delays in receiving confirmation from partners. For example, the fifth ex post evaluation, which was originally planned to start in FY24, will now only begin in FY25.
- 44. The AF-TERG secretariat have already started the procurement for three pieces of evaluative work in FY25, namely the thematic evaluation on readiness, the fifth ex post evaluation and the training modules under the Evaluation Policy.
- 45. The procurement processes for the comprehensive evaluation and the MTR of MTS2 are ready to start following clearance of the ToRs by the Board. The AF-TERG is also awaiting confirmation for the sixth ex post evaluation from relevant governmental counterparts in order to commence that procurement. Finally, AF-TERG expects to finalize the ToR on the evaluation of processes, systems and governance of the Fund by December 2024. Finalization of all of this work will guarantee reaching at least 80 per cent of execution of the evaluation budget in FY25.
- 46. The continuous use of more rigorous budget and contract management tools, as well as better planning by the AF-TERG secretariat, are expected to improve expenditure management in FY25 and allow for efficient delivery of the first year of the second multi-year work programme.

# Annex 2: Summary of external outreach activities by the AF-TERG in FY24 and the beginning of FY25

#### FY24

- 1. The AF-TERG held its fourth in-person meeting in July 2023 in Malaga, Spain, to critically assess emerging findings from the rapid evaluation, discuss forward work planning including emerging findings from the recent survey to AF stakeholders, and to discuss and refine ongoing work on ex post evaluations, thematic studies, and the introduction of the Evaluation Policy guidance notes to key stakeholders. The meetings discussed "hot topics" that each of the evaluation units was working on and facilitated knowledge and lesson sharing.
- 3. Mr. Vladislav Arnaoudov, AF-TERG Secretariat Coordinator/Senior Evaluation Officer, participated virtually in the eighth Asia-Pacific Adaptation Network (APAN) Forum in August 2023 in Songdo, Incheon, South Korea.
- 4. Mr. Vladislav Arnaoudov, AF-TERG Secretariat Coordinator/Senior Evaluation Officer, participated in sessions of the Accreditation Panel meetings on 6 September 2023 and 8 February 2024 in Washington, DC., United States.
- 5. Ms. Debbie Menezes, AF-TERG Chair, and Mr. Vladislav Arnaoudov, AF-TERG Secretariat Coordinator/Senior Evaluation Officer, participated in the annual NIE seminar in Santo Domingo, Dominican Republic, in the period 12–15 September 2023. The event was attended by over 20 NIEs and provided an opportunity for the AF-TERG to have in-depth interactions with NIEs particularly on the Evaluation Policy and their forward evaluation priorities.
- 6. Ms. Susan Legro, AF-TERG member, participated in the Adaptation Futures Conference in Montreal, Canada, in October 2023. She held a masterclass on the ex post evaluation methodology that has been developed by the AF-TERG and piloted in four countries so far.
