The secretariat will also report on the matter of NEMA of Kenya failing to sign the legal agreement following approval of a readiness package grant approved to NEMA on behalf of the government of Kenya, and the expiration of NEMA's accreditation with the Fund. NEMA had been the intermediary supporting the accreditation of a second NIE in Kenya under the approved readiness package grant.
