



## Small Grants Latest Updates

Learning Grants and Bundling

At the 42<sup>nd</sup> meeting , the Board decided to:

- (a) To approve the increase of learning grants from the current US\$ 150,000 per project to US\$ 500,000 per project to provide support for national implementing entities in capturing and disseminating practical lessons from adaptation interventions;
- (b) To request the secretariat:
  - (i) To prepare operational policies for the learning grant window, reflecting the change in project scale;
  - (ii) To prepare, through a consultative process, a proposal for a framework approach for bundling with small grants; and

(iii) To present the outputs of the work described under subparagraphs (b) (i) and (b) (ii) above to the Project and Programme Review Committee at its thirty-fourth meeting.

• <u>(Decision B.42/34)</u>



Main objectives of learning grants are:

- (a)Transferring knowledge from one NIE to another;
- (b)Transferring knowledge from NIEs to the wider climate finance adaptation community and
- (c)Developing knowledge and guidelines through partnerships.
- The goal of learning grants is to help encourage a culture of learning across institutions and help build NIE capacities in knowledge management. They represent a window of opportunity to capture, study and disseminate practical lessons from adaptation interventions that are additional to KM activities already financed under Adaptation Fund-approved projects/ programmes.
- Learning grants represent an opportunity for implementing entities to develop knowledge products as well as setting up a knowledge management system for effective management and dissemination of learning material. Additionally, they aim to complement collaborative knowledge and sharing efforts with respect to partnerships with diverse stakeholders on the ground.

- MTS-II IP calls for stronger linkages among pillars generally, and Innovation and Learning-and-Sharing specifically (develop options and policies for bundling innovation grants with other small grants)
- Combining resources and accessing funding via a single submission template:
  - Streamlined process
  - Planning projects and programmes more holistically, including alignment with NAPs and NDCs
  - More efficient allocation of resources to critical areas of innovation and learning
  - By leveraging the strengths of both innovation and learning, integrated projects can achieve more comprehensive and sustainable results
  - Combining innovative solutions with dedicated learning components, bundled projects can create a virtuous cycle of innovation, application, and continuous improvement.
- NIE-driven interest already apparent some proposals seem relevant/eligible for both innovation and learning grants.
- This is a pilot that may lead to insights on how to bundle different types of grants.



### Harmonized Costs and fees

- The harmonization of EE costs and IE fees across the various windows aims to reduce confusion for IEs and simplify calculations by IE as well as reduce risk of errors in the review and oversight process by Secretariat.
- a) Regarding IE fees, the limit is to be:
- i. i. For single country projects and programmes, 8.5% of total project/programme cost for all funding windows;
  - ii. For regional projects and programmes, 10% of total project/programme cost for all funding windows;



### Harmonized Costs and fees

#### • (b) Regarding the EE costs:

- i. Where the EE is different from the IE, for single country projects and programmes, the limit is to be 9.5% of total project/programme and, for regional projects and programmes, 10% of total project/programme cost for all windows, with the following specifications:
  - 1. In line with Decisions B.13/17 and B.38/42, to require the IE to provide justification as part of its proposal submission if requesting costs beyond the cap on an <u>exceptional</u> case-by-case basis;

• ii. Maintain the principle of the separation between implementing and execution services and that EE costs would be capped at 1.5% if IE executes the projects or part of it pursuant to Decisions B.17/17, B.18/30 and, also recalling the option of flexibility with justifications on a case-by-case basis, Decision B.38/42.

Increasing the size of the PFG to better provide for the actual needs of undertaking key assessments and required consultations and could therefore be expected to enhance the quality of the proposals.



Additional PFG funding for LLA projects to support activities that enable devolving decision making to local actors & to enable local actors to make informed decisions on how adaptation actions are defined, prioritized, designed and implemented.



### Project formulation grants (PFG)

- The limits for PFG grants were amended since AFB42 as follows:
- 1. For single country projects across all windows [regular and large innovation are accessible through NIEs, RIEs and NIEs
  - a. Project size below US\$2M = PFG amount US\$50,0000
  - b. Project size US\$2M to US\$5M = PFG amount US\$100,000
  - c. Project size US\$5M and above =PFG amount US\$150,000
  - d. LLA projects = PFG amount US\$150,000 plus additional PFG up to US\$100,000. (to tap into the additional US\$100,000 requests will be evaluated on a case by case basis)
- 2. For *regional projects across all windows* 
  - a. Project size US\$5M and above with less than three countries = PFG amount of US\$150,000
  - b. Project size US\$5M and above with 3 and above countries = PFG additional amount of US\$15,000 per additional country up to a maximum of US\$250,000.
- When a 3-step approach is used, the maximum amount of PFG that can be requested at Pre-concept stage is limited twenty percent 20% of the maximum total PFG applicable to the project.

- For single country projects US\$ 2 million and above but below US\$ 5 million the limit is set at US\$ 100,000;
- For single country projects US\$ 5 million and above, the limit is set at US\$ 150,000;

#### PFG for LLA projects:

- For single country LLA projects US\$ 150,000 in PFG support.
- Additional PFG amount up to a maximum of US\$ 100,000 and will be evaluated on a case-bycase basis as per the provided justifications

#### <u>Regional projects under all</u> <u>funding windows:</u>

- For all regional projects of US\$ 5 million and above with less than three countries, the limit is set at US\$ 150,000.
- The limit can increase by US\$ 15,000 for each additional country involved, up to a maximum of US\$ 250,000.

#### PFG for projects submitted using three-step approach:

 When a 3-step approach is used, the maximum amount of PFG that can be requested at the preconcept stage is twenty percent (20%) of the maximum total PFG applicable to the project.

Requests for a PFG should be made at the same time as the submission of a project concept or pre-concept to the secretariat using the revised PFG form in Annex I of document AFB/PPRC.33/40.
